Plaintiffs' Voluntary Dismissal Without Prejudice Pursuant to Stipulation

Plaintiffs filed a lawsuit on November 16, 2020, challenging the constitutionality of Kansas' eyebrow threading licensing regime. (Doc. 1.) Plaintiffs sought declaratory judgment and injunctive relief on the grounds the licensing regime violated Kansas' life, liberty, and pursuit of happiness clause (Kan. Const. Bill of Rights, Sec. 1), Kansas' due process of law clause (Sec. 18), and under Kansas' equal protection clauses.

During the pendency of the litigation, the Kansas Legislature passed, and the Governor signed into law, Kan. Leg. 2022 SB 348, entitled, "AN ACT concerning public health; relating to cosmetology; hair removal; exempting persons engaged in threading from the practice of cosmetology and the requirements thereof; amending K.S.A. 65-1901 and 65-1928 and repealing the existing sections."

In light of Kan. Leg. 2022 SB 348, the parties stipulate to a dismissal without prejudice pursuant to KSA § 60-241(a)(1)(A)(ii), with the parties to bear their own costs and fees.
